

## Camp site regulations

The Dünencamp Karlshagen welcomes you. Our camp meets a 5-star standard and all our staff will do their best to make your time at the Dünencamp as pleasant as possible. The Dünencamp is open to all guests who are willing to comply with the campsite rules and regulations and contribute to a pleasant atmosphere on the site through their behaviour. Excluded from the use of the campsite are persons who act in a serious manner contrary to the regulations of the campsite rules, to the detriment of the operator, its employees and other guests, commit or have committed criminal offences or serious misdemeanours, or have committed or are committing criminal offences or serious misdemeanours, or have committed or have committed any other reckless behaviour towards other guests and employees. If such behaviour is detected during the stay on the campsite, the operator will exclude these guests from using the campsite with immediate effect and without notice. In the event of such behaviour in the past, the operator is entitled to reject a registration for a new stay.

### Our rules in detail:

1. Access to the campsite is only allowed after registration. Please report to the reception first. The Dünencamp staff may inspect the identity cards of each camping guest and visitor. Before finally leaving the campsite, the camping guest must check out at the reception.
2. The fees for the use of the campsite must be paid in accordance with the valid price list.
3. Only guests who are free of infectious diseases according to § 6 of the Infection Protection Act have access to the campsite. With your registration you declare that you and the persons accompanying you are free of such diseases. Culpable, false statements not only result in exclusion from the campsite, but also in the obligation to pay compensation, especially in the event of quarantine and closure measures ordered by the authorities.
4. All guests are obliged to maintain order and cleanliness on the campsite. All guests will treat the facilities and equipment with care. Damage to trees, entering the dunes and lighting open fires is strictly forbidden.
5. During cleaning times, the respective buildings will be closed to visitors. The instructions of the Dünencamp staff and the specialised staff must be followed, especially with regard to parking vehicles, ensuring order and safety and allocating parking spaces.
7. Dogs of all sizes must be kept on a leash at all times. When visiting the beach, the "dog beach" signposted for this purpose must be used.
8. It is not permitted to surround the stand area with trenches and fences. Tent pegs, tent cords and other accessories must be installed in such a way that nobody is endangered or disturbed.
9. All kinds of waste must be disposed of by the campers at the central collection point in the designated waste containers. You can get the corresponding waste bags free of charge at the reception.

10. The camping site is closed from 12:00 to 14:00 and from 22:00 to 08:00. During this time no motor vehicles are allowed to enter the campsite. During these times, the registration lanes in front of the reception must be used for parking vehicles, and the use of radios and other entertainment devices is only allowed at the volume of the tent. Loud conversations and other noisy activities are prohibited during this time.
11. Vehicles of all kinds may only be driven at walking speed on „Karlchens Allee“ and the access roads in the areas "Forest", "Sun" and "Sea".
12. The campsite is reserved for recreation seekers. It is prohibited to carry on any business on the site and requires prior permission from the local authority.
13. It is prohibited to sublet pitches or rent out accommodation (e.g. campers, caravans, tents) for profit, as well as to place rental advertisements or similar.
14. The management and the groundsman are entitled, in the exercise of their domiciliary rights, to refuse to receive persons and to expel them from the site if this seems necessary to maintain order and security on the campsite in the interest of the campsite guests.
15. The site must be vacated by 12:00 a.m. on the day of departure.
